# **JOB SUMMARY**

Under general supervision, performs technical and specialized skilled work as related to the lines maintenance functions. Work involves performing internal inspection of the collection system with a camera to evaluate the defects in the system including services; cleaning lines; rating the defects in the line segment; and counting and identifying service location.

# **ESSENTIAL JOB FUNCTIONS**

- Inspects mainlines, lateral lines, and manholes with a camera for closed circuit television (CCTV).
- Uses Global Positioning System (GPS) unit to log sewer features such as clean-outs, manholes, sewer taps, etc.
- Replaces and/or repairs camera equipment.
- Receives and/or reviews various records and reports such as safety training, work orders, and maps.
- Prepares and/or processes various records and reports such as spare parts lists, pretrips for vehicle, line conditions, and repair work orders.
- Refers to equipment manual, maps, drawings, policy and procedure manuals, codes, laws, regulations, publications, and reference texts, etc.
- Operates a variety of vehicles, machinery, and equipment such as inspection van, cleaning truck, vacuum equipment, lateral camera, electronic locators, etc.
- Interacts and communicates with various groups, individuals, and members of the general public.
- May respond to service calls in emergencies or after hours.
- Assists with by-pass pump set-up.
- Performs other related duties as assigned.

#### **Licenses or Certifications:**

- Valid South Carolina driver's license.
- Must obtain a Class "D" Wastewater Collection System certification within 6 months
  of hire.
- Must obtain NASSCO PACP, LACP, and MACP certification within six (6) months of employment.

## Special Qualifications:

 Able to use or learn to use a variety of tools such as cable roller, camera, tractor, footage counter, etc.; a variety of vehicles, machinery, and equipment such as inspection van, cleaning truck, vacuum equipment, lateral camera, etc.; and a variety of supplies such as light bulbs, bridle, scotchcast resin, general office supplies, etc.

# **Knowledge, Skills and Abilities:**

- Knowledge of the laws, ordinances, standards, and regulations pertaining to the specific duties and responsibilities of the position.
- Knowledge of basic computer systems to include Windows XP, Word, and Excel.
- Knowledge of the common practices, tools, methods, and techniques used for position.
- Knowledge of the occupational hazards and proper safety precautions involved in wastewater treatment operations.
- Skill in use and care of common tools and equipment employed in the maintenance and installation.
- Skill in operating vehicles and machinery used for the position.
- Ability to detect and repair malfunctions in lines.
- Ability to understand and follow oral and written instructions.
- Ability to read and interpret technical materials pertaining to the responsibilities of the job.
- Ability to prepare required records and reports with accuracy and in a timely manner.
- Ability to perform required mathematical calculations with accuracy.
- Ability to establish and maintain effective working relationships as necessitated by work assignments.

### PHYSICAL DEMANDS

The work is medium to heavy work. This requires exerting up to 75 pounds of force occasionally; and/or up to 30 pounds of force frequently; and/or a negligible amount of force constantly to move objects. Additionally, the following physical abilities are required: crouching, feeling, grasping, handling, hearing, kneeling, lifting, mental acuity, pulling, pushing, reaching, repetitive motion, speaking, standing, stooping, talking, visual acuity, and walking.

# **WORK ENVIRONMENT**
